### 5.3 Realisation of the objectives

All five objectives have been achieved and summarized as follows.

- 1. A basic understanding of the interaction between post-70s writers, Hong Kong (HK) literary scene and HK society was achieved. The investigation was achieved through two channels. First, series of background information and primary materials (1997-2016) have been collected. They included: (a) publication and circulation of 10 significant literary magazines/supplements (index with 4674 entries); (b) formation, activities and publication of 7 important local literary societies (66 books, 7 magazines and 120 articles in total); (c) post-70s writers' public engagement/social contact and literary activities in common spaces (about 220 activities); (d) other historical background information, e.g. important political and social event, views or debate related to literature and society (216 articles/books). Given the limited and fragmented nature of the information, supplementary materials were also collected through the second channel, i.e., interviews with 14 post-70s writers (grouping in 7 pairs to explore in-depth dialogues, conducted from 2019 to 2021, transcribed into 300,000 words transcript). The 14 writers provided us with first-hand information and descriptions about the literary scene and general cultural environment of HK in the past decades, as well as their various interaction with literary scene and society. Together with the overall library research, a clearer picture of the post-97 HK literary scene is reconstructed for the first time.
- 2. The analysis of the post-70s writers' self-imagination as public man was completed. This was achieved mainly through writer-oriented approach and textual analysis, with references to writers' self-reflection in interviews. The PI identified 14 post-70s writers for case studies and interviews. The PI and the research assistant (RA) collected materials related to the 14 writers and prepared a brief bibliography for each writer (about 2500 entries in total). Each bibliography covered the works of the writer (books and pieces published in journal/newspaper supplement/new media), and study/review on the writer (academic papers/theses, books, reviews, interviews, etc.). Related materials from websites and new media were also covered. The PI closely read the texts and analyzed how the writers represented and reflected the outside world and inner self in their textual world. It has led to a comprehensive understanding of the characteristic of the post-70s generation, especially their linkage with reality and HK society.
- 3. The probe of the role of literature in post-97 HK society was also completed. This was achieved mainly through analyzing the linkages between post-70s writers' writings and their social context. The interviews also collected writers' views on the relationship between literature and society. The PI analyzed the post-70s HK writers' treatment of social issues, e.g., globalization, urbanization, animal rights, psychological illnesses, social movements, etc. Through literary and social analysis, the PI probed into the function of literary representation and lyrical expression to understand the alternative role of literature in society.
- 4. Likewise, the illustration of the relevance of literature to the formation of post-97 HK public sphere was achieved. Based on the findings of objective (3), this objective on the one hand was achieved through re-visiting Habermas' concept of "public sphere" in the view of Jacques Rancière and Martha C. Nussbaum. On the other hand, it was also illustrated by the retrospection of classical left-wing's theoretical argument on realism, e.g., György Lukács, Roger Garaudy. The visibility of literature in public was also observed, including the debate on "literature and society" in newspapers and new media, on-site literary acts in social movements, etc.
- 5. The evaluation of the influence of multimedia and new media on post-97 HK literature was basically achieved. This was achieved through evaluating their influence on the formation of writers' translocal imagination, writing style, and new form of expression. However, due to rapid changes of internet environment, some of the old materials, e.g., websites, webpages, blogs, and literary forums in early 2000s could not be accessed anymore. The collection of newspapers from the Mainland was also difficult under COVID-19 situation. Due to the missing of primary text, the influence of multimedia and new media cannot be always examined through textural analysis of

"black-and-white" archives. The evaluation was limited and was mainly relied on the published works and the information collected in the interviews.

# 6.1 Major findings and research outcome (Maximum 1 page; please make reference to Part C where necessary)

This project is the first comprehensive study of post-70s HK writers, with special focus on literary publicness. Major findings can be summarized into three aspects.

- 1. The study of post-70s writers: Despite the diversity in terms of works and writing styles, post-70s writers are similar in having global literary citizenship and the identity of a cosmopolite. The development of internet shortens the distance between cities and areas and creates expedite connection of people with no boundaries. The rise of new media and social media also quickens the circulation of news and knowledge. In the cases of post-70s writers, the writing of reality is often diversified into different cultural issues. Through various avant-garde writing experiments of fiction, prose and poem, Lee Wai-yi (李維怡), Hon Lai-chu (韓麗珠), Cheung Yuen-man (張婉雯), Lee Chi-leung (李智良), Lo King-chi (盧勁馳) and Chan Lai-kuen (陳麗娟), recontextualized global cultural issues such as urbanization, urban redevelopment, animal rights, globalization, psychological illnesses, physical disabilities, gender issues in different regional context and situation. They thereby construct the linkage between local HK and the world from a literary-oriented position. In the case of Liu Wai-tong (廖偉棠) and Lee Chi-leung, there is also a refraction of mobility of identity and the imagination of translocality. Moreover, it is observed that the two streams, realism and modernism, those once representing two entirely writing circles in HK literature are merging together. The cross-over of literature and multimedia also suggested that post-70s writers have started a generation of "connection".
- 2. The role of literature and its significance in public sphere: According to the analysis of literary works, interviews and literary activities, most post-70s writers do not treat literature as sounding-board for political beliefs or direct statement, or as a tool for intervention of social events. They believe that literature is more about affect and reflective thoughts. The nature of defamiliarization of literature empowers the writers to revisit reality from a distance. In the case of

Lee Wai-yi's ghostly writing, the writer tries to break through the limitations of reality through various mysterious elements. Literature also creates alternative "partage du sensible" for the community (Jacques Rancière). The literary imagination is important to our public life because it would re-define a kind of "poetic justice" (Martha C. Nussbaum). The above arguments can be obviously examined in the case of animal writing by Hon Lai-chu and Cheung Yuen-man. Although the importance of literature is declining in the era of digital image, literature has remained an important component of ideology. It is still thought-provoking and can stimulate discussion and debate in social media and public events.

3. The limitation of the concept of "post-70s writers": In response to the suggestions of the reviewers, the project includes various writer-oriented case studies with textual and social analysis. The case studies altogether provide a comprehensive understanding of the post-70s generation, while each of them retains to reflect the unique characteristics of one's own to go beyond the limitation of generational studies. Moreover, although the project argued that post-70s writers have similar literary ethics and the identity of a cosmopolite, it does not imply that writers other than post-70s do not share these characteristics. Among all 14 interviewees, both Lawrence Pun Kwok Ling (潘國靈) and Chan Chi Tak (陳智德) were born in 1969 but still share similar literary ethics and worldview of most post-70s writers. It is noted that there is much vagueness in generational studies. The term "post-70s writer" can be treated as an easy and clearcut working concept for setting study area of a research project. It is suggested that Giorgio Agamben's "the Contemporary"(同時代人) may be a wider concept that can be applied for the studies of post-97 HK literature. As the formation of post-97 HK is highly complicated, the dialogues and memories of 14 writers are valuable research material which provides witness for the changes in HK. The transcript of the interviews would be edited into a book of 150,000 words for publishing.

# 6.2 Potential for further development of the research and the proposed course of action (Maximum half a page)

The investigation of the background information has enriched the understanding of the literary field of post-97 Hong Kong. The study of "publicness" can be extended to cover the whole post-97 HK literature, including writers of different generations. The interviews have also provided valuable and useful first-hand materials for writer-oriented literary studies. The research can be extended to in-depth studies of individual post-70s writers. Hon Lai-chu, Dorothy Tse, Lee Wai-yi, Lee Chi-leung have been in the spotlight especially in recent years. It can be foreseen that the academia will gradually pay more attention to some of the well-established post-70s Hong Kong writers. For example, Prof. David Der-wei Wang discussed Lee Wai-yi's fiction in an international seminar in April 2022. PI's journal paper on Lee Wai-yi is well received and it has been cited in Taiwan. Further studies on post-97 literature can help to evaluate the significance of post-70s generation in the history of Hong Kong literature. The brief bibliographies, indexes and other primary materials can be made publicly accessible to facilitate further studies.

The research can be extended to some comparative studies about realism / modernism in different periods of Hong Kong literature. Hong Kong writers of realism in 1960s-1970s (e.g., Shu Xiang Cheng (舒巷城), Hei Xi (海辛)), and the modernists who were closely related to 1960s-1970s student movement (e.g., Ko Siu Sun (古兆申), Chong Ling Ling (鍾玲玲), Wan Kin Lau (溫健騮)) can be further explored. After the paper on Lee Wai-yi's writing of realism, the PI has extended the studies of realism in Hong Kong literature to the case of Shu Xiang Cheng's fiction in 1950s. It will be covered in PI's another ongoing FDS research project on representation of soundscape. The research has also been extended to an inter-institutional research project on the modernist in 1960s. To further investigate Ko Siu Sun and Wan Kin Lau, the PI joined a RGC General Research Fund (GRF) project as co-investigator. (Project Title: "Creating Writing Pedagogy during the Cold War: The University of Iowa's International Writing Program and Hong

Kong Poets", no. 12607419, 2019/09-2022/02, PI: Prof. James Shea, HKBU). PI's finding was presented in an online symposium "Transpacific Creative Writing Pedagogy: The University of Iowa and Asian Writers during the Cold War", with the title of "Union Press, literary field and cultural circulation" in Hong Kong Baptist University on 2020/05/21.

### 6. Layman's Summary

This project is the first comprehensive study of post-70s Hong Kong writers, with special focus on literary publicness. Through the investigation of series of background information (1997-2016) and writers' interviews, a clearer picture of post-97 HK literary scene is reconstructed for the first time. In post-97 Hong Kong, literary magazines edited by post-70s intellectuals were no longer of pure literature, but full of cross-sectorial topics that echoed the society. This project includes various writer-oriented case studies with textual and social analysis, altogether they provide new understanding of the identity, literary ethics, and worldview of post-70s writers by probing into the complicated relationship between literature, media, and society. Despite the diversity in terms of works and writing styles, post-70s writers are similar in having global literary citizenship and the identity of a cosmopolite. Through imagination and introspection, they express their concerns over global cultural issues such as globalization, urbanization, gender, animal rights, psychological illnesses in different regional context. They thereby construct the connection of the local and the world and participate in the public sphere from a literary-oriented position. The emphasis on the importance of new media also illustrates the study of literature in the internet era and informational society.

### 9. Whether Research Experience And New Knowledge Has Been Transferred / Has Contributed To Teaching And Learning

Based on the findings of this project, the PI explored some works of post-70s Hong Kong writers which are suitable for teaching and learning in tertiary-level courses. The new knowledge has enhanced the PI's teaching of Hong Kong literature and creative writing in the following modules of BA-Chinese programme:

- "CHI3007 Modern and Contemporary Chinese Prose Selected Readings and Writing";
- "CHI3009 Contemporary Chinese Literature and Society";
- "CHI4006 Appreciation and Writing of Modern Chinese Fiction";
- "CHI5000 Thesis"

The works of Liu Wai-tong, Hon Lai-chu, Dorothy Tse and Tang Siu Wa have been selected for students' reading and application. Some significant topics covered in this research project such as "the role of literature in society" and "the relevance of literature to the formation of public sphere" were also discussed with theoretical references. The teaching materials and discussion have inspired the students very much. The knowledge transfer can be further observed in 4 students' thesis. They all have extended the reflection about "literature and society / history" to their studies on Hong Kong writers of post-97 periods.

8 undergraduate students of Department of Chinese were invited to transcribe the interviews into editable transcripts for further processing. Students gained some basic research experiences, knowledge of Hong Kong post-97 literature, and enhancement in the use of Chinese language.

Due to limitation of resources, instead of holding a symposium on "literary publicness" in the University, the PI has organized a series of talks for exchanging views on above topic. The activities were held in The Institute for Chinese Language and Culture and/or Department of Chinese, Hang Seng University of Hong Kong. Some target writers of this FDS project were invited to share their works and literary opinions. The online talks provided a public platform for discussion, which hundreds of undergraduate and postgraduate students from different universities could participate in enthusiasm. In these 3.5 years, the on-site/online activities have created interesting, inspiring, and fruitful learning experience for students continuously. The details of talks series of post-70s Hong Kong writers are as below:

The PI's journal paper on Lee Wai-yi is well received and has led to more studies of Hong Kong 70s writers. It has been cited in a conference paper by a post-graduate student in Taiwan. The PT was invited to be the discussant of this paper. The paper, "Feminine Writing and Dynamic Dimension of Hong Kong left-wing—A case study of Lee Wai-yi's *Agarwood* "(香港本土左翼的 女性書寫與能動向度——以李維怡《沉香》為例), was presented in The Conference "Criticality: Hong Kong Studies and Its Discontents" (臨界:香港研究及其不滿) which was organized by Institute of Social Research and Cultural Studies, National Yang Ming Chiao Tung University (國立陽明交通大學), 2022/03/26.

In 2021, the PI was invited by Hong Kong Arts Development Council to write a review for Lee Chi-leung's new book, "Gaze and Resonance: Reading *Day We Cross* by Lee Chi-leung" (凝視與 共感:讀李智良《渡日若渡海》), helping to evaluate the quality of funded book project.

The PI was invited to participate 5 activities for public that provided good impact for knowledge transfer. The talks and seminars introduced the books and recent publications of some post-70s writers whom were covered in this research project. The PI severed as moderator in the section, "Illness Narratives in Literary Writings" (文學的疾病書寫), of the Symposium: Literature and Life (研討會:「文學與人生」) in the 12<sup>th</sup> Hong Kong Literature Festival(第十二屆香港文學節). The symposium was organized by Hong Kong Public Libraries and was held on 2018/07/07. Hon Lai Chu is one of the presenters. There were about 80 audiences.
- 2. The PI severed as one of speakers in the online seminar "Writing in a Difficult Era: On *The Ghost in the Umbrella* and *Owlish*" (在艱難的時代創作:談《無遮鬼》與《鷹頭貓與音樂箱女孩》) on 2021/03/13. This is the 11<sup>th</sup> Literature and Cultural Salon (文學文化沙龍) co-organized by the Research Centre for Chinese Literature & Literary Culture of The Education University of Hong Kong, and Hong Kong Literature Research Centre of The Chinese University of Hong Kong. The PI discussed Dorothy Tse's two new books with the author and shared her observation on Tse's writing.
