#### 5.1 Objectives as per original application

- 1. Collate the text of Chuci and recover its original form through comparing the variants of the transmitted texts and juxtaposing it with the related excavated materials.
- 2. Reevaluate previous scholarship and use Chuci to decipher the characters appeared in the excavated texts through the incorporation of evidence derived from philology, phonology and semasiology.
- 3. Assess the cultural contents of Chuci through a juxtaposition of the text with recent archaeological findings, and probe into the relationship between the culture of Chu and the transmitted work.
- 4. Identify the time when certain vocabularies, nomenclatures and institutions appear and use this as a base to re-examine the dates of composition of each Chuci piece.
- 5. Develop two databases, namely "the Excavated Texts and the Revision of Chuci Database" and "the Bibliography for the Study of Chuci and Excavated Texts," and upload them onto the Internet so as to allow researchers to run searches.

All objectives have been realized with significant research output. The details are as follows:

For objectives 1 and 2, this project aims at combining archaeological findings with the study of the transmitted version of *Chuci*. The recently discovered excavated manuscripts and the findings of previous studies have been collected and sorted out, and these data were successfully uploaded to the project website. The words found in the excavated texts that correspond to the received version of *Chuci* are juxtaposed on the project website which can be used to collate the variants and interpret the meaning of the text. Using the graphs that appeared in excavated materials as reference, this project assessed the meaning of *Chuci* and examined its cultural context. The methods of philology, phonology and semasiology were also applied to explore the meaning of the text. The preliminary findings were presented in several conferences and published as book chapters and journal articles.

For objective 3, this project investigated the relationship between the culture of the Chu and the transmitted work of *Chuci*. By incorporating excavated materials into the study of the text, this project analyzed the divination and sacrificial practices in the history of the Chu and explained why a shaman is often deployed to communicate with the gods and spirits in the text "Lisao". To acquire a deeper understanding of the culture and customs of the Chu state, this project also explored the ethnic origin of the author of "Lisao" and analyzed the antiquities and objects of *Chuci* through the studies of their rituals, architecture, clothing and utensils.

For objective 4, this project developed a database which consist of two sections: "Interpretation of *Chuci* with the Use of Excavated Texts" and "Bibliography of *Chuci* Studies and Excavated Texts." The former lists how different scholars interpret the text of *Chuci* with the use of newly excavated bamboo strips and silk manuscripts. It also juxtaposes the words found in the excavated texts that correspond to the received version of *Chuci*. The latter allows researchers to search for secondary scholarship on *Chuci* and the related excavated texts. It covers most scholarly work conducted in China and East Asia published before 2020. The references included in this database are grouped into five categories: monograph, journal paper, book chapter, conference paper, and thesis. The database has been made available for public access since June 2021.

#### 6. Research Outcome

6.1 Major findings and research outcome *(Maximum 1 page; please make reference to Part C where necessary)* 

The research findings of the project have been presented in international conferences and published in journals, book chapters, and released on the project databases as given in Part C. The major findings are summarized as follows.

#### 1. Collation and Interpretation of *Chuci* through Excavated Materials

*Chuci* has already been transmitted for more than two thousand years. Hence, there are a considerable number of variants and misprints in different versions of the text. This project collated the text of *Chuci* through comparing the variants of the transmitted texts and the related excavated materials and achieved the planned results. It proves that the incorporation of excavated materials is beneficial to the studies of ancient text. For example, in "Lisao" [Encounter Sorrow], the character *mu* 畝 [a unit of land] can be written in various forms 畒, 畒 or 晦 in the different versions of *Chuci*. Using the Chu-style characters that appeared in the excavated materials as reference, the project noticed that *mu* 畝 were often written as 晦. It proves that the character 晦 is used to refer to the unit of land measurement in the Warring States period and infers that this written form 晦 is the character used in the original *Chuci*. This project also presented some newly excavated texts and materials that can lay a solid foundation for interpreting the meaning of *Chuci*.

## 2. The Formation and Compilation of Chuci

A sixteen *juan* version of *Chuci* was first compiled by Liu Xiang (77-6 BCE) in the Western Han. It is normally assumed that Liu's work served as a base text for the 2<sup>nd</sup> century scholar Wang Yi's compilation *Chuci zhangju* [the Annotated Songs of Chu]. However, by examining the *Chuci* text together with the supplementary excavated bamboo-slip manuscripts, this project contends that this assumption is flawed. The findings will shed light on the process of the formation and compilation of *Chuci*.

#### 3. Examination of the Chu Culture by Comparing *Chuci* and the Excavated Materials

Through the excavated Materials, this project enhanced our understanding of the Chu culture and its religion. In terms of cultural origin, the Chu people mainly accepted the primitive mythological culture of the 夏夷 Xiayi clan, rather than the ritualized culture of the Western Zhou Dynasty in the north. Therefore, Qu Yuan's "Tianwen" preserved the worship of the earth gods of the Xia people. In the "Lisao", the descent of the divine spirits is not necessarily initiated by the activities of the shaman. Instead, the Chu people believed they have the agency to ascend and descend according to their will. With the help of the excavated materials, this project has probed into the daily lives of the people in Chu, such as clothing, food, housing and transportation, which was reflected in *Chuci* 

## 4. The Development of a Database of Chuci Studies and Excavated Texts

Since excavated materials are stored in different places and are printed in various publications, it is difficult for scholars to locate the manuscripts specifically related to *Chuci*. This project developed a database to solve this problem. This database will certainly provide a solid foundation for future

research. The introduction of a digital tool into the study of *Chuci* allows researchers to not only reevaluate the flaws of previous scholarship, but also conduct a more thorough research on specific subfields of *Chuci*.

6.2 Potential for further development of the research and the proposed course of action (Maximum half a page)

The excavated texts recently discovered by the Tsinghua University have just been released at the end of the project and the bamboo strips related to *Chuci* collected by the Anhui University have not been published before the completion date of the project. Further studies on these newly excavated manuscripts will provide a richer understanding of *Chuci* and the culture of Chu. The PI will analyze the relevant data and keep updating the project database once the new materials are released.

#### 7. Layman's Summary

Since the 20th century, the excavation of a large number of historical texts has stimulated great enthusiasm in the study of ancient books. *Chuci* is often listed as the first text among all literary works in traditional bibliographies and exerts crucial influence in the Chinese literary traditions. Yet in the study of *Chuci*, scholars are more inclined to study the various editions of the received text. This project seeks to combine archaeological findings with the study of transmitted texts to decipher the characters that appeared in the ancient text and provide an accurate interpretation of *Chuci*. Not only would this research help us to locate the misprints, but it can also serve as evidence for us to provide a solid interpretation of *Chuci*. Hence, with an accurate text, this project shall serve as a foundation for the study of the mythology, aesthetics and folklore of the Chu state. It can also enhance our understanding of the details and development of Chu culture and provides us with significant insights into the formation and development of Chinese literature and culture. This project created the first digital database for *Chuci* with excavated materials that can allow the researchers to conduct a more thorough study on specific fields.
