#### 5.3 Realisation of the workplan

I am delighted to report that all the activities planned for the grant period were successfully completed. I had proposed to complete my research interviews and some additional library work in 2018, on the topic of musical publics in Mumbai city and the emergence of a new Indian idea of the interiorized subject of Hindustani music. As I drafted the monograph based on this research, I was able to finesse the relationship between subjectivity and sociality as mediated by music.

I came up with the concept 'metropolitan unconscious' to capture the collective histories of the migrants who had brought Hindustani music to Mumbai in the late 19<sup>th</sup> and early 20<sup>th</sup> centuries, as well as the diverse population of the city that moved there to live and work, and be entertained. I have argued that through listening to and appreciating the music, and even learning it in the mushrooming music schools across the city and through individual discipleship, the inhabitants of Mumbai became 'performing subjects', displaying their modern identities by yoking their contemporary lives to a sense of the past.

This argument was elaborated over the 300 pages of the manuscript: beginning with an Introduction where I laid out the key concepts informing the research, followed by 5 chapters and an Afterword. Chapter 1 provided the historical background for the rise of Hindustani music in Mumbai; Chapter 2 explored the spaces of music (for both performance and pedagogy) in the native town; Chapter 3 dwelt on the 'excessive subject', the person madly in love with music; Chapters 4 and 5 discuss the means by which musicophilia was secured – through new pedagogies suited to the non-traditional learner. The Afterword shows how the research was taken into the space of the gallery, even as it underpinned the documentary film, *Phir se samm pe aana* (Returning to the first beat), directed by Surabhi Sharma, premiered at the Mumbai International Film Festival.

In the grant period, the manuscript was submitted to Duke University Press, went through two rounds of peer reviews, has been copyedited and designed, and is scheduled to be out in February 2020.

By the time the monograph is published in February 2020, the remaining website work will also be completed.

<u>Presentation of findings</u>: I presented the findings of my research at the Association of Cultural Studies conference in Shanghai (August 2018) and at the Inter-Asia Cultural Studies conference in Dumaguete (August 2019). I have also given talks based on the research at Stanford University, University of California Santa Cruz, and UCLA in May-June 2019.
