



6.3 Realisation of the objectives

(Maximum 1 page; please state how and to what extent the project objectives have been achieved; give reasons for under-achievements and outline attempts to overcome problems, if any)

This project was intended to organize an international conference on heritage conservation along the Belt and Road zones. Due to the COVID-19 pandemic, the 2-day conference on 23-24 October 2020 was held in a hybrid mode. the participants including keynote speakers and panelists agreed that further discussion (in the form workshop) on the political dynamics among heritage professionals and local community stakeholders along Belt and Road zones was necessary before the end of June 2021. Since the spending for organizing the conference was significantly reduced, the project team decided to organize 3 additional seminars in April and May 2021.

The project objectives have largely been achieved.

Regarding the first objective, the conference stated at the outset that the roles of UNESCO in "making" world heritage along Belt and Road zones are essential. The process of nomination, approval, and management of world heritage not only relies on UNESCO framework but also domestic political and socio-economic consideration. 6 papers presented at the conference analyze the contributions and challenges of UNESCO in the Silk Road heritage making process. Subsequent to the conference, a workshop on UNESCO's heritage conservation initiative was held in May 2021 to introduce new framework - the Cultural Heritage Site Management Competency Framework

Regarding the second objective, 8 papers presented in the conference addressed China's heritage diplomacy along Belt and Road Zones. One the one hand, most of papers set state-driven attempt to channel resources and knowledge of heritage conservation to other BRI countries. Bottom-up efforts in heritage diplomacy on the other hand should not be ignored. By providing different cases along the Belt and Road Zones, the papers demonstrate the impacts and diversity of China's BRI heritage diplomacy

Regarding the third objective, most of papers in the conference touched on the dynamics between politics and professionalism in the process of heritage making and management. 3 papers specifically addressed how scholars and professionals contributed to the "construction" of New Silk Road and its relevant to heritage conservation. However, the roles of local community in BRI heritage conservation were not significantly addressed along the conference. So, subsequent to the conference, two workshops related to branding local community in BRI heritage tourism and collaboration between local community, state, and international actors on heritage conservation during COVID-19 were organized in April 2021. The speakers highlighted the importance of community involvement and multi-level cooperation.

On deliverables, an edited volume of selected conference papers has been accepted for publication in "Asian Heritage" by International Association of Asian Studies and Amsterdam University Press. The book is tentatively scheduled to be published in 2023.



7. Research-Related Outcome

7.1 Potential for development into research proposal and the proposed course of action (Maximum half a page)

This project provided a platform for researchers in the field of heritage politics and Belt and Road Initiative (BRI) to discuss the current practice of heritage conservation along Belt and Road Zones. PI and one of Co-Is have planned to prepare a research proposal in relation to China-Iran heritage cooperation under BRI.

7.2 Research collaboration achieved (Please give details on the achievement and its relevant impact)

An edited volume of selected conference papers has been accepted for publication in "Asian Heritage" by International Institute of Asian Studies and Amsterdam University Press. Eleven papers were included in the edited volume, entitled *Heritage Conservation Along Belt and Road Zones: Between Politics and Professionalism*, and is tentatively scheduled to be published in 2023 (Please refer to Annex I for details). The book offers a multilateral approach to studying heritage conservation experiences across Asia, Africa, and Eurasia. Through the in-depth analysis undertaken in each chapter, the book analyses the dynamics between politics and professionalism in promoting national agendas and/or enhancing international cooperation of heritage conservation among countries along the Silk Roads. It has three major themes: (1) the construction of new Silk Roads discourses by academics, heritage professionals in international organisations, and government officials; (2) the negotiation of inscription and the management of Silk Roads heritage sites; and (3) the practice of China's heritage diplomacy through its Belt and Road Initiative (BRI), including its contribution and challenges.

7.3 Any new development and/or challenging research topic(s) has / have been identified and any new initiative(s) for future research has / have been inspired.

Due to the prevalence of COVID-19 pandemic, heritage conservation faces unprecedented challenges in terms of financial resources and conservation work delay etc. On the one hand, it is imperative to further investigate the details of challenges ahead. On the other hand, "new normal" on heritage conservation after COVID-19 such as rapid development of digitizing heritage conservation and tourism should be addressed and examined.

8. The Layman's Summary

Recent developments in heritage conservation have gone beyond a mere professional act of preserving the historical past but have increasingly been utilized by the state to display its soft power and diplomatic importance across the globe. In particular, the Chinese government's Belt and Road Initiative (BRI), in addition to its regional economic contribution, also serves as a new platform for international cooperation of heritage conservation.

The project included a two-day conference featuring two keynote speeches as well as five panel sessions and three additional workshops by distinguished scholars and practitioners in the field of heritage studies and international relations for an in-depth discussion on the politics of heritage conservation along the Belt and Road zones in comparative perspective. The project therefore worked to enrich our understanding of (1) the role of international institutions such as UNESCO in facilitating and monitoring BRI initiatives heritage conservation; (2) cooperation and conflicts between China and other BRI countries involved in heritage sites or projects; (3) the critical assessment of the role of professionalism on heritage conservation projects under BRI; and (iv) the impacts of local forms of resistance and negotiation with respect to cultural heritage development practices and how state actors respond to them.
