² "Plagiarism" refers to the intentional or unintentional appropriation of another person's ideas, processes, or results or words (including diagrams, figures, tables, photos, etc.) without providing appropriate credit or acknowledgement.

³ "Self-plagiarism" refers to cases where the researchers reuse their own data or previously published work (including working papers), or parts of it, in the proposal or a subsequent publication, research paper or other output of the funded project, without appropriate acknowledgement that the material had previously been published.
