# MISSION STATEMENT OF THE UGC 教資會工作目標

The UGC is the non-statutory body which advises the Government of the Hong Kong Special Administrative Region on the funding and strategic development of higher education in Hong Kong. In this role, the UGC works with universities, the Government and the community to promote excellence in the higher education sector, with a view to establishing Hong Kong as the education hub of the region and to nurturing high quality people to promote the economic, cultural and social development of Hong Kong. The UGC will:

- (a) oversee the deployment of funds for the strategic development of the higher education sector;
- (b) support the continuous development of the higher education sector to achieve greater impact and recognition, and as a source of innovation and ideas for the community;
- (c) give steering advice to the higher education sector from a system perspective and facilitate universities to fulfill their distinctive roles;
- (d) enhance the student experience and advance the international competitiveness in teaching, research and knowledge transfer by universities in accordance with their agreed roles;
- (e) facilitate the sustainable development of higher education to meet the demands of the changing times;
- (f) encourage deep collaboration among universities to develop an interlocking system to increase international competitiveness of the sector; and
- (g) safeguard quality and promote efficiency, cost-effectiveness and accountability in the activities of universities.

In carrying out the above activities, UGC seeks to preserve institutional autonomy and academic freedom, in the context of appropriate financial and public accountability.

教資會為非法定的獨立組織,就香港高等教 育的經費撥款安排及策略性發展,向香港特 別行政區政府提供意見。為此,教資會致力 與各大學、政府及社會各界人士共同努力, 務求令高等教育界達至卓越水平,把香港發 展為區內教育樞紐,同時培養高質素人才, 以推動本港經濟、文化及社會蓬勃發展。教 資會的職能包括:

- (a) 負責經費調配,以配合高等教育界的策 略性發展;
- (b) 支持高等教育界不斷發展,以發揮更大 的影響力及得到廣泛認同,並成為社會 創新思維和意念的泉源;
- (c) 在整體層面向高等教育界提供方向性意 見,並協助各院校發揮其獨特角色;
- (d) 優化學生的學習經驗,並促使院校按本 身的角色,提升在教學、研究及知識轉 移範疇的國際競爭力;
- (e) 促進高等教育界持續發展,以配合時代 轉變的需要;
- (f) 鼓勵院校深入協作,令香港高等教育界 得以發展成一個互相緊扣的體系,以提 高整體的國際競爭力;以及
- (g) 確保院校維持質素,並推動各院校提升 各項工作的效率、成本效益和問責性。

在執行上述工作時,教資會在恰當地向公眾 及在財務上問責的前提下,將致力維護院校 自主和學術自由。



The UGC has under its aegis two semi-autonomous bodies: the **RGC** is responsible for advising the needs of higher education institutions in academic research, and considering applications for research grants from academic staff and for the award of fellowships; and QAC is responsible for advising on quality assurance matters in the higher education sector, including specifically the conduct of quality audits of the UGC-funded universities.

### **UGC-Funded Universities**

There are eight universities in Hong Kong funded through the UGC:

City University of Hong Kong (CityU) Hong Kong Baptist University (HKBU) Lingnan University (LU) The Chinese University of Hong Kong (CUHK) The Education University of Hong Kong (EdUHK) The Hong Kong Polytechnic University (PolyU) The Hong Kong University of Science and Technology (HKUST) The University of Hong Kong (HKU)

The eight UGC-funded universities are statutorily autonomous bodies governed by their own ordinances and governing councils. They enjoy academic freedom and considerable institutional autonomy. The UGC Notes on Procedures clearly state that universities enjoy autonomy in the development of curricula and academic standards, selection of staff and students, initiation and conduct of research, internal allocation of resources. Meanwhile, the universities are also accountable to the public given the significant government funding and community contributions the universities receive. They are also expected to commit to transparency and accountability in their operations to ensure that funding is put to the appropriate use that serves the best interests of the community and students.

教資會轄下有兩個半獨立組織,分別是研 資局和質保局。**研資局**負責就本港高等教 育院校在學術研究上的需要向政府提出建 議、審批學術人員的研究撥款申請以及發 放獎學金;**質保局**負責就香港高等教育界 的質素保證事宜提供意見,包括對教資會 資助大學進行質素核證。

### 教資會資助大學

現時透過教資會取得撥款的本地大學共有 八所:

香港城市大學(城大) 香港浸會大學 (浸大) 嶺南大學(嶺大) 香港中文大學(中大) 香港教育大學(教大) 香港理工大學 (理大) 香港科技大學(科大) 香港大學(港大)

八所教資會資助大學均是獨立自主的法定 機構,受其條例和校董會規管,並享有學 術自由和相當大的院校自主權。教資會的 《程序便覽》清楚訂明,大學無論在制訂 課程與學術水平、甄選教職員與學生、提 出與進行研究,以至內部調配資源方面, 均享有自主權。鑑於各大學獲龐大的政府 資助及社會捐獻,大學亦須向公眾負責。 大學應致力就其運作保持透明度和向公眾 負責,確保大學的經費用得其所,符合社 會和學生的最佳利益。





















### Committee Structure (as at 31 March 2023) 教資會架構(截至2023年3月31日)

Membership of the UGC (as at 31 March 2023)

As at 31 March 2023, the UGC comprised 24 members (including the Chairman) who were appointed by the Chief Executive in their personal capacity. Among them, there were 14 local members comprising eminent community leaders and academics of high standing. The remaining members were from the Mainland and overseas, including two members from the Mainland as well as eight from around the world (including New Zealand, Singapore, South Africa, the United Kingdom and the United States).

As the work of the UGC is closely related to the higher education sector of Hong Kong as well as the local community, local scholars and members of the community may contribute by taking part in the work of the UGC to ensure that our higher education aligns with the development direction of our country and Hong Kong and meets societal needs. Furthermore, the higher education sector of Hong Kong is highly internationalised and well-connected to reputable institutions around the world for student mobility and research collaborations. Members from the Mainland and overseas enable the UGC to offer comprehensive views to the Government, which is conducive to enhancing the global competitiveness of our higher education sector, thereby contributes to Hong Kong's development into an international hub for post-secondary education.

### 教資會委員名單(截至2023年3月 31日)

截至2023年3月31日,教資會共有24名委員 (包括主席)。教資會全體委員均以個人身分 由行政長官委任,當中14名屬本地委員,包 括傑出社會領袖和學術權威,餘下則為內地 及海外委員,包括兩名來自內地及八名來自 全球各地(包括紐西蘭、新加坡、南非、英 國及美國)的學者。

教資會的工作與本港高等教育界及社會息息相關,本地學者及社會人士可透過參與教資會的工作,確保高等教育切合國家及香港的發展方向及回應社會所需。另一方面,本港的高等教育高度國際化,與世界各地院校在學生交流及研究協作均關係密切。委任內地及海外學者可讓教資會向政府提出更豐富全面的意見,有助提升本港高等教育界的環球競爭力,為香港發展為國際專上教育樞紐作出貢獻。





# CHAIRMAN 主席 Mr Tim LUI, GBS, JP 雷添良先生, GBS, JP

Mr Tim Lui is the Chairman of the Securities and Futures Commission. He is also a member of the Public Service Commission.

Mr Lui is a Fellow Member of The Hong Kong Institute of Certified Public Accountants (HKICPA) and a Member of The Institute of Chartered Accountants in England and Wales. He was elected President of the Hong Kong Society of Accountants in 1997.

Mr Lui joined PricewaterhouseCoopers (PwC) in 1978. During his career at PwC, he served as the Senior Tax Partner, Lead Director of the Board of Partners and a member of the Global Board. He retired as a Senior Advisor of PwC in 2018.

Mr Lui has been active in public and community service. In the past, he was Chairman of the Education Commission, the Committee on Self-financing Post-secondary Education, the Joint Committee on Student Finance, the Standing Commission on Directorate Salaries and Conditions of Service as well as the Employees' Compensation Insurance Levies Management Board.

雷添良先生是證券及期貨事務監察委員會 主席。他亦是公務員敍用委員會的委員。

雷先生是香港會計師公會的資深會員和 英國及愛爾蘭特許會計師協會的會員。 雷先生在1997年當選為香港會計師公會 的會長。

雷先生於1978年加入羅兵咸永道會計師事務 所。在羅兵咸永道工作期間,他曾出任高級 稅務合夥人、合夥人董事會的首席董事及環 球董事局的成員。他於2018年離任時為羅兵 咸永道高級顧問。

雷先生多年來活躍於公共及社會服務。過 往,他曾任教育統籌委員會、自資專上教 育委員會、政府助學金聯合委員會、首長 級薪俸及服務條件常務委員會及僱員補償 保險徵款管理局的主席。

# Professor Chris BRINK, BBS Chris BRINK教授, BBS

- Emeritus Vice-Chancellor, Newcastle University, UK
- Former Rector and Vice-Chancellor, Stellenbosch University, South Africa
- 英國紐卡素大學榮休校長
- 南非斯泰倫博斯大學前任校長

Professor Chris Brink served as Vice-Chancellor of Newcastle University from 2007 till 2016. Before that he was Vice-Chancellor of Stellenbosch University in South Africa, and before that Pro-Vice-Chancellor (Research) at the University of Wollongong in Australia, Head of Mathematics and Coordinator of Strategic Planning at the University of Cape Town, and Senior Research Fellow at the Australian National University. In the UK he served on the Board of Universities UK (where he chaired the Student Policy Network), the Board of the Quality Assurance Agency, the Board of the Equality Challenge Unit, and as Chairman of the N8 (the eight major research-intensive universities in the North of England). He holds the Freedom of the City of Newcastle, and is a Fellow of the Royal Society of South Africa.

Chris Brink教授在2007年至2016年期間出任英國紐卡素大學校長。在出任該職前,曾任南非斯泰倫博斯大學校長。在接掌斯泰倫博斯大學前,他歷任澳洲臥龍崗大學副校長(研究)、開普敦大學數學系主任兼策略規劃統籌主任,以及澳洲國立大學高級研究員。在英國,他曾任英國大學聯合會(Universities UK;並擔任該會的學生政策網絡主席)、質素保證局(Quality Assurance Agency)及平等促進組(Equality Challenge Unit)理事會成員,並擔任N8研究伙伴(英格蘭北部八大研究型大學)主席。他獲紐卡素市頒授自由榮譽,並為南非皇家學會會士。

### Professor David CARDWELL David CARDWELL教授

- Pro-Vice-Chancellor (Strategy and Planning), University of Cambridge, UK
- 英國劍橋大學副校長 (策略及規劃)

Professor David Cardwell is Professor of Superconducting Engineering and Pro-Vice-Chancellor responsible for Strategy and Planning at the University of Cambridge. He was Head of the Engineering Department between 2014 and 2018. Professor Cardwell, who established the Bulk Superconductor Research Group at Cambridge in 1992, has a world-wide reputation on the processing and applications of bulk high temperature superconductors. He was a founder member of the European Society for Applied Superconductivity (ESAS) in 1998 and has served as a Board member and Treasurer of the Society for the past 14 years. He is an active board member of three international journals, including Superconductor Science and Technology, and has authored over 400 technical papers and patents in the field of bulk superconductivity since 1987. He has given invited presentations at over 70 international conferences and collaborates widely around the world with academic institutes and industry. Professor Cardwell was elected to a Fellowship of the Royal Academy of Engineering in 2012 in recognition of his contribution to the development of superconducting materials for engineering applications. He was awarded a Sc.D. by the University of Cambridge in 2014 and an honorary D.Sc. by the University of Warwick in 2015.

David Cardwell教授現為劍橋大學超導工程 學系教授暨副校長,負責策略及規劃,他在 2014至2018年期間擔任該校工程系院長。 1992年, Cardwell教授在劍橋成立大型超導 體研究組 (Bulk Superconductor Research Group),在處理和應用大型高溫超導體的領 域,享譽國際。1998年,他創立歐洲應用超 導學會 (European Society for Applied Superconductivity),在過去14年一直出任 該會的董事和司庫。他積極參與三份國際期 刊的編輯委員會工作,包括《超導體科學技 術》(Superconductor Science and Technology)。自1987年起,他撰寫逾 400篇有關大型超導範疇的技術論文並獲 得專利。他曾獲邀在超過70多個國際研討 會上擔任講者,亦與世界各地多間學術機 構和業界合作。Cardwell教授於2012年獲 授皇家工程院院士榮銜,以表揚他積極研 發超導物料在工程學的應用,為有關範疇 貢獻良多。他在2014年獲劍橋大學頒授理 學博士學位,並於2015年獲華威大學頒授 榮譽理學博士學位。

Ms Diana Cesar is a General Manager of the HSBC Group. She is also Executive Director and Chief Executive of Hang Seng Bank Limited, Chairman and Non-executive Director of Hang Seng Bank (China) Limited, Chairman of Hang Seng Insurance Company Limited and Chairman of the Hang Seng Index Advisory Committee of Hang Seng Indexes Company Limited.

Prior to joining Hang Seng Bank, Ms Cesar was Chief Executive of HSBC Hong Kong. She was responsible for steering the business to achieve its strategic objectives by managing client relationships and business partnerships, coordinating with the government and regulatory bodies, and improving employee well-being. She was a member of the Executive Committee for The Hongkong and Shanghai Banking Corporation Limited.

During a wide-ranging career with HSBC, Ms Cesar held leadership roles in marketing, credit cards, consumer loans and mortgages. She was Head of Retail Banking and Wealth Management in Hong Kong and Regional Head of Distribution Strategy and Consumer Propositions for Asia Pacific. Earlier in her career at HSBC, she was seconded to Taiwan as Head of Credit Cards and successfully turned the business around.

Prior to joining HSBC, Ms Cesar was General Manager for Customer Relations for SmarTone Telecom. She has also worked in Canada and Hong Kong for other global financial institutions, including Citibank and American Express.

施穎茵女士是滙豐集團總經理。她亦是恒生銀行有限公司執行董事兼行政總裁、恒生銀行(中國)有限公司董事長兼非執行董事、恒生保險有限公司董事長及恒生指數有限公司的恒生指數顧問委員會主席。

在加入恒生銀行前,施女士曾擔任香港滙豐的行政總裁。她透過客戶管理及建立夥伴合作關係,並與政府及監管機構協調,推動滙豐的業務發展以達致其策略目標,同時改善僱員福祉。她亦曾為香港上海滙豐銀行有限公司執行委員會成員。

施女士於滙豐集團內擁有豐富經驗,曾在市場推廣、信用卡、消費貸款和按揭等業務部門出任要職,並曾擔任香港零售銀行及財富管理業務主管及亞太區分銷策略及客戶提案主管。此前,施女士曾被借調至台灣,出任信用卡部門主管,期內成功將該項業務轉虧為盈。

# Professor Alan CHAN Kam-leung 陳金樑教授

- Provost and J.S. Lee Professor of Chinese Culture The Chinese University of Hong Kong
- 香港中文大學常務副校長及利榮森中國文化教授

Professor Alan Chan is Provost and J.S. Lee Professor of Chinese Culture at The Chinese University of Hong Kong (CUHK). He received his Ph.D. from the University of Toronto, Canada, in Chinese and Comparative Philosophy and Religion. From 2009 to 2019, he served as Toh Puan Mahani Idris Daim Professor of Humanities, Dean of the College of Humanities, Arts, and Social Sciences, and Vice-President at Nanyang Technological University, Singapore (NTU). Prior to joining NTU, he was Professor of Philosophy and Associate Provost for Undergraduate Education at National University of Singapore (NUS). While at NUS, he was twice awarded the Teaching Excellence Award. He was a member of the Founding Editorial Board, Oxford Bibliographies of Chinese Studies; Chairman of the Board of Directors, Confucius Institute, NTU; Co-Chair, Governing Council, NTU Centre for Contemporary Art, Singapore; member of the Board of Directors, Consortium of Humanities Centres and Institutes, and Singapore Examination and Assessment Board; and is currently a member of the Board of Directors, International Confucian Association, Vice-Chairman of the Board of Directors of Shenzhen Institutes of Advanced Technology of the Chinese Academy of Sciences, Director of the Association of Pacific Rim Universities (APRU), and member of the Governing Board of The Chinese University of Hong Kong, Shenzhen. His online module, "Explorations in Confucian Philosophy", a MOOC on Coursera has attracted over 10,000 learners. Born and raised in Hong Kong, he joined CUHK in January 2020.

陳金樑教授為香港中文大學 (中大) 常務 副校長及利榮森中國文化教授。陳教授於 多倫多大學取得中國與比較哲學及宗教研 究博士學位。2009至2019年間,歷任新加 坡南洋理工大學(南大)文學院講座教授 (Toh Puan Mahani Idris Daim Chair Professor of Humanities),人文、社會科 學、藝術設計與傳播信息學院院長及副校 長。此前為新加坡國立大學 (NUS) 哲學教 授及協理副校長(本科教育)。於NUS任 教期間,曾兩度獲頒卓越教學獎。陳教授 先後出任《中國研究牛津在線參考書目》 的創始編輯委員會成員、南大孔子學院理 事委員會理事長、南大當代藝術中心管理 委員會聯合主席、Consortium of Humanities Centres and Institutes理事會成員、新加 坡考試與評鑑局成員; 現為中國國際儒學 聯合會理事會成員、中國科學院深圳先進 技術研究院理事會副理事長及香港中文大 學 (深圳) 理事會成員、環太平洋大學聯 盟董事。陳教授所開發名為「Explorations in Confucian Philosophy」的網上教學課 程,在Coursera平台吸引了過萬名人士修 讀。陳教授在香港出生及成長,於2020年1月 加入中大。

Dr Chan is the Advisor of Council of the Hong Kong Chinese Orchestra, Board Chairman of the Hong Kong Schools Dance Association, Chairman of the Sha Tin Arts & Culture Promotion Committee, Founding Member of the Hong Kong Direct Subsidy Scheme Schools Council, Fellow Member of the Hong Kong Institute of Directors. He has also been appointed as QAC Member since 1 April 2022.

陳偉佳博士現為香港中樂團理事會顧問、香 港學界舞蹈協會董事會主席、沙田文化藝術 推廣委員會主席、直資學校議會始創委員、 香港董事學會資深會員。他亦在2022年 4月1日獲委任為質保局成員。

# Professor Tim CHENG Kwang-ting 鄭光廷教授

- Vice-President for Research and Development Hong Kong University of Science and Technology
- 香港科技大學副校長(研究及發展)

Professor Tim Cheng is Vice-President for Research and Development (VPRD) and Chair Professor jointly in the Electronic & Computer Engineering (ECE) and Computer Science & Engineering (CSE) Departments at The Hong Kong University of Science and Technology (HKUST). He is also the Director of InnoHK AI Chip Center for Emerging Smart Systems which aims to advance IC design to help realize ubiquitous AI applications in society.

At HKUST, Professor Cheng served as Dean of Engineering for 6 years prior to taking the current role of VPRD. Prior to joining HKUST in 2016, he was on the faculty of the University of California, Santa Barbara where he also served in various administrative roles including ECE Department Chair and Associate Vice-Chancellor for Research.

An internationally leading researcher with extensive experience in fostering cross-disciplinary research collaboration, Professor Cheng is a world authority in the field of electronics design verification and testing, as well as covering a wide range of research areas including design automation of electronic and photonic systems, computer vision, and medical image analysis.

鄭光廷教授現為香港科技大學(科大)副校長(研究及發展),並兼任電子及計算機工程學系以及計算機科學及工程學系的講座教授。他亦是「智能晶片與系统研發中心」的中心主任 - 這個由特區政府「InnoHK創新香港研發平台」撥款資助成立的研究中心旨在促進集成電路設計的技術發展,以助實現人工智能在社會獲廣泛應用。

成為科大副校長前,鄭教授於科大工學院 擔任了6年院長;加入科大前,鄭教授於美 國加州大學聖塔芭芭拉分校曾先後擔任多 個領導職位,包括電機及計算機工程學系 系主任及協理校長(研究)。

鄭教授是國際知名的研究者,在推動跨學 科研究合作的範疇上擁有豐富經驗。他是 電子測試及設計驗證的權威,其研究涉及 多個學術領域,包括電子及光電子系統的 設計自動化、計算機視覺,以及醫學影像 分析對等。

### Professor Arnoud DE MEYER Arnoud DE MEYER教授

- Former President Singapore Management University
- 新加坡管理大學前校長

Professor Arnoud De Meyer is a global academic leader with more than 35 years of experience in top international academic institutions in Europe and Asia. Until December 2018, he served as President of Singapore Management University (SMU). Before joining SMU, Profession De Meyer was from 2006 until 2010 Director (Dean) of the Judge Business School at the University of Cambridge (United Kingdom). From 1983 until 2006, he was a faculty member at Institut Européen d'Administration des Affaires (INSEAD) and assumed between 1990 and 2006 several management positions, among others as founding dean of INSEAD's Asia campus in Singapore.

Professor De Meyer has been an Independent Director of several companies in Belgium, France, Singapore and Australia. Currently he is Independent Director of Viva Energy Pty Ltd (Australia). He is also the Chair of the Temasek sponsored "Stewardship Asia Centre" (Singapore).

He is an internationally recognised researcher in the areas of Research and Development and Innovation Management, Manufacturing Strategy and International Management. He published more than 100 academic articles and 12 books. His most recent book "Ecosystem Edge: Sustaining Competitiveness in the Face of Disruption" was published in 2020 with Stanford Business Press.

Arnoud De Meyer教授是全球享負盛名的學術 界領袖,任職歐洲和亞洲頂尖國際學術機構 超過35年。他曾任新加坡管理大學校長,直 至2018年12月。加入新加坡管理大學前, De Meyer教授於2006至2010年期間擔任英 國劍橋大學嘉治商學院院長。他在1983至 2006年期間任職歐洲工商管理學院 (INSEAD) 教學人員 ,並在1990至2006年歷 任多個管理層職位,其中包括於歐洲工商管 理學院亞洲(新加坡)校區出任創院院長。

Professor Mark Kamlet is University Professor of Economics and Provost Emeritus at Carnegie Mellon University (CMU). He served as Carnegie Mellon's Provost (Chief Academic Officer) and Executive Vice President from 2000 to 2014. Prior to that he was Dean of the Heinz College for seven years.

During his time as provost, CMU's technology commercialisation operations were significantly revamped; two academic departments were created (Machine Learning and Biomedical Engineering); the University advanced in technology-enhanced learning; and the University established campuses and academic presences in Doha, Kigali, Adelaide, Lisbon, Silicon Valley, Los Angeles and Washington DC.

Professor Kamlet is on the Board of Highmark Inc., a national, diversified health insurance and health care delivery company, and the Jewish Healthcare Foundation. He was Chairperson of the Board for 12 years of Carnegie Learning, Inc. and for 5 years of iCarnegie, Inc., both Carnegie Mellon spinouts. He has served on the Board of other start-up companies and is currently on the Board of Everspring Partners. Kamlet is Co-Director of the Living Analytics Research Center, a joint research centre located in Singapore, a joint centre of Carnegie Mellon University and Singapore Management University. It focuses on the application of new technologies and software platforms relevant to Singapore's Smart Nation efforts. He sits on the university-level President's Tenure and Academic Committee of Singapore Management University.

He earned a B.S. in Mathematics from Stanford, and an M.S. in Mathematical Statistics and Ph.D. in Economics from University of California at Berkeley.
